### **GENERAL INFORMATION**

CHEMSURF 90 is a general purpose, low foam non-ionic spreader/activator for use on plants to maximize the effectiveness of herbicides (aquatic and terrestrial), insecticides, fungicides and other pesticides. It is designed for quick wetting, uniform droplet distribution and increased spray retention on leaf and stem surfaces. CHEMSURF 90 incorporates the properties of a spreader and an activator to improve wetting, spreading, contact activity and penetration.

### **DIRECTIONS FOR USE**

With herbicides (aquatic and terrestrial), insecticides, fungicides, defoliants and desiccants: Add 1 to 4 pints per 100 gallons of water during mixing. For specific rates of surfactant, always refer to the pesticide manufacturers' label.

**NOTE**: Needed rates of CHEMSURF 90 may vary with conditions of application. Sufficient CHEMSURF 90 should be added to form a smooth, uniform spray deposit.

Prior to use, read and follow all directions on this label and on the label of the pesticide being used. The pesticide manufacturer's label for specific usages and restrictions have precedence over DIRECTIONS FOR USE referred to on this label.
